Businesses will need to provide their own candy, and the DAO will provide balloons. Bayside is providing carnival games for the sidewalks and inflatables for the Square.

Matt shared details about the costume contest, which will be hosted by Amber & Tanner, and take place at 6pm on the Square.

Cadance is working on a map that shows all the candy locations. This will be shown on the LED screen, as well as on cards distributed to participating businesses.

#### 6.0 ICE RINK UPDATES

Cadance provided details about the Ice Rink, which will open around November 19 and go through January 9. She is partnering with nonprofit groups to run the rink. There will also be the annual tree lighting, as well as holiday markets. The Chamber and VSR are coordinating all the marketing.

Sponsorships are still be secured to fund the installation and she will send the packet out to the whole committee after the meeting.
