REMINDER: Sonoma County Small Business Stabilization Grant Program is Open through Sunday, October 18

Small businesses in Sonoma County with between 1 and 30 employees can apply for grants of \$2,500 to \$15,000 in Covid-19 relief funding to use towards expenses including payroll, utilities, rent or mortgage expenses.

Small business owners should be prepared to apply with the following necessary documents:

- Copy of Business License OR Copy of Utility Bill in Business' Name
- Total pre-Covid-19 and Current Employment Figures
- Annual Business Income

The application window closes Sunday October 18th, at 11:59pm, and recipients will be notified by the end of October.
